- 1. Registration fee is due when registration is complete.
- 2. Fees are due the first day of attendance, each week. Late payments will be subject to a fee of \$35.00 per week. A late fee of \$40.00 will be charged for the weeks of Christmas and New Years.
- 3. Children not on the full-day program will be charged the hourly fee for any time beyond the program hours.
- 4. A 10% discount is given to the lower priced program for families with more than one child enrolled, if paid within the same week of service.
- 5. For children picked up after our normal closing time there is a late charge of **\$25.00** within the first 15 minutes and \$15.00 for every 15 minutes after.
- 6. Breakfast snack, two (2) snacks and hot lunches are included in fees.
- 7. No credit is given when a child is absent or not attending their regularly scheduled time. This includes all holidays, vacations and sick time. One week per year will be given at half credit per child, after 6 consecutive months of enrollment. The child will need to be out the full week in order to receive that credit. (Refer to Policy Handbook).
- 8. Returned checks will be subject to a \$40.00 surcharge.
- 9. A 2-week written withdrawal notice is required after a child has begun attendance.
- 10. Monthly payments made at the beginning of each month for current month will receive a 2% discount. These payments will need to be made on the first day of attendance for that month.
- 11. All schedules less than 5 days per week are based on availability.
- 12. A half day is defined as up to 5 hours.
